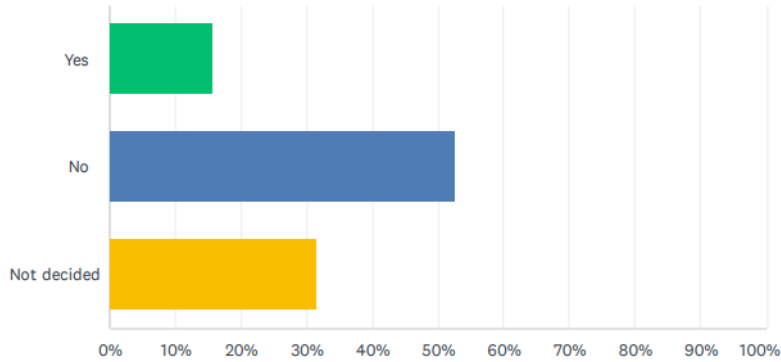

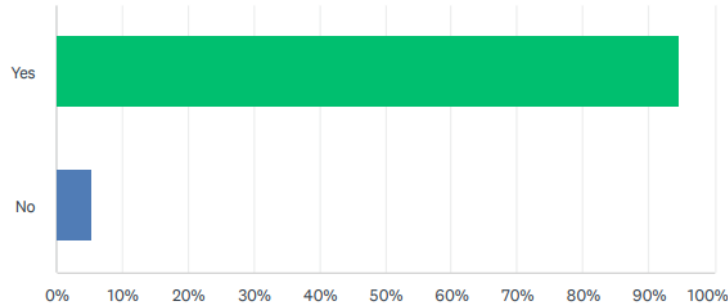

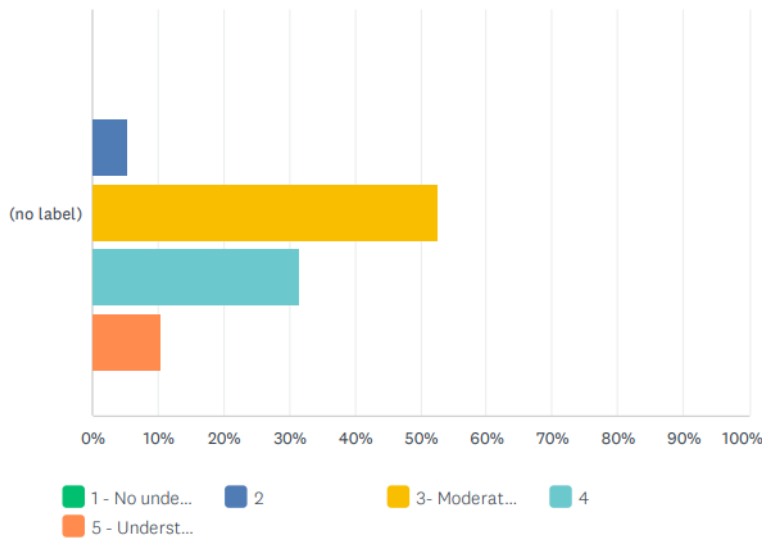

Q8 On a scale from 1-5, how would you rate your current understanding of energy storage technologies?

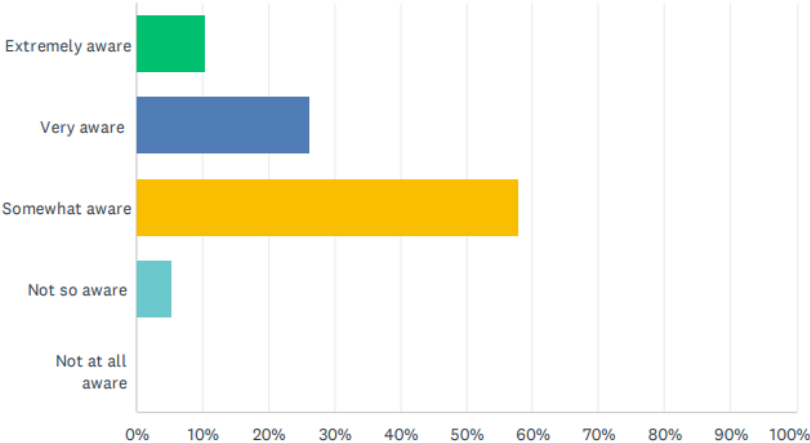
