The Economic Development Department is recruiting a key member of the investment attraction team to support Council's strategic priority of Economic Prosperity and the City's Corporate Business Plan. This position will be responsible for executing and implementing tactics outlined in the City's Investment

Attraction Strategy, which is aimed at attracting investment to Lakeview Business District, a key employment district, intended to be build-out over the coming decades.

The core responsibilities of the role include:

- Leading the development and execution of investment attraction and business attraction initiatives specific to the industrial portfolio and Lakeview.
- Serving as an industry expert, being the primary contact for prospects related to the industrial attraction portfolio, participating in outbound industrial and sector specific investment attraction activities.
- Leveraging relationships with the commercial and industrial real estate industry, leading presentations, organizing meetings, tours, calls and discussions.
- Fostering relationships with landowners within Lakeview and facilitate development and/or divestment.
- Managing the procurement of contracts related to acquisition, divestment, or development of City-owned land in Lakeview, such as property appraisals, studies, environmental site assessments, real estate services, or land development services
- Acting as developer/applicant for the City in applying for building and development-related permits for City lands in lakeview, such as subdivisions, redistricting, and development.

QUALIFICATIONS

- A bachelor's degree in a field related to economic development, such as business, marketing, business management, land development, commercial real estate, or land planning, coupled with a minimum of 5 years of related experience.
