# Articles of Amendment

Not-for-Profit Corporations Act, 2010

**Corporation Name (Date of Incorporation/Amalgamation)**  
TWENTY VALLEY TOURISM ASSOCIATION (December 21, 2001)

**1. The name of the corporation is changed to:**  
ST. CATHARINES LINCOLN DESTINATION PARTNERSHIP

**2. The number of directors or the minimum/maximum number of directors are amended as follows:**  
**Minimum/Maximum** Min 3 / Max 15

**3. The purposes of the corporation are amended as follows:**

The term "Twenty Valley" in the purposes of the Corporation is hereby replaced with "the Niagara Benchlands and St. Catharines region". After giving effect to the foregoing, the following shall be the purposes of the Corporation:

The purposes of the Corporation are the establishment and operation of a Merchants Association for the purpose of:

- a) attracting customers to the Niagara Benchlands and St. Catharines region and creating an atmosphere which will encourage customers to return;
- b) promoting and encouraging fair and courteous dealings with customers; and
- c) promoting and encouraging ethical business practices;

and such other complementary purposes not inconsistent with these purposes.
